Call For Nominations

How to Submit a Nomination:

- 1) Complete and submit the "Call for Nominations" form and select an award category.
- 2) Include support information, which must be typed on no more than two 8 1/2 x 11 white paper, double-spaced. You may submit additional support information such as news clippings or letters of support. The deadline to submit a nomination is **February 15, 2008**. You may submit multiple nominations but each require a separate form.

How to Support Your Nomination:

- 1) Describe the individual's or organization's activities and identify the issue or need addressed.
- 2) Describe how Sacramento's children and families have benefited from these activities.

Inspirations 2008 is the Child Abuse Prevention Council's premier event to honor extraordinary individuals who work tirelessly on behalf of children and families.

At one of Sacramento's most prestigious award luncheons, the Council will honor three extraordinary persons or agencies for their work performed on behalf of children and families. The event will be held on May 16, 2008 at the Sacramento Convention Center.

The deadline to submit nominations is **February 15, 2008**. The guidelines to submit nominations are on the reverse side of this form. You may nominate more than one candidate, but each nomination requires a separate form.

◆ **Business or Philanthropy Award**

Awarded to a business, corporation or individual for their contributions of volunteerism or financial commitment to improve the lives of children in our community.

◆ **Community Service Provider Award**

Awarded to an educator, school or school district, legal advocate, law enforcement professional, fire department, social services provider, medical provider, not-for-profit organization, or other organization/individual that has provided leadership and commitment to the prevention of child abuse and neglect, or commitment and leadership in safeguarding children through advocacy or representation through the legal system, or provided leadership in developing innovative and creative solutions to better serve children and families.

◆ **Hearts & Hands Award**

Awarded to a community volunteer, youth or adult whose dedication and commitment have benefited children and families, or an exemplary leader or advocate whose work has made an extraordinary difference in the lives of children and families, or a person who has overcome challenges and now works or volunteers on behalf of children and/or families.
